



# Aia Tatau i Falefaigaluega i totonu o Ausetalia

## O ai e iai aia tatau i totonu o falefaigaluega i Ausetalia?

O tulafono faigaluega a Ausetalia e puipuia ai tagata faigaluega i lo latou nofoaga autū o galuega o lo'o i Ausetalia, po o i latou fo'i o lo'o faigaluega mo se kamupani Ausetalia. E le mana'omia i tagata faigaluega ona avea ma tagatanu'u Ausetalia po o ni tagata nofo tumau ina ia puipuia i lalo o tulafono o galuega i Ausetalia.

E tutusa aia tatau ma puipuiga o galuega mo i latou e umia visa ma tagata uma o lo'o faigaluega i Ausetalia. E lē mafai e konekarate po o maliega ona aveesea nei aia tatau.

## O fea ou te alu ai mo se fesoasoani?

O le Fair Work Ombudsman<sup>1</sup> (FWO) e nafa ma le fa'amalosia o tulafono o galuega i totonu o Ausetalia.

O le FWO e iai meafaigaluega aoga i luga o le upega tafailagi e mafai ai ona e siaki lou totogi ma fa'aaoga le pay calculator.<sup>2</sup> E vave ma faigofie ona fa'amaumau ou itula faigaluega i le fa'aaoga mai o le Record My Hours app - Fair Work Ombudsman.<sup>3</sup>

Afai o e popole i le lē lelei le faiga o oe e lau falefaigaluega pe lē usita'i i tulafono o galuega i Ausetalia, e mafai ona e fa'afeso'ota'i le FWO mo fa'amatalaga, fautuaga, po'o se fesoasoani. E mafai ona e valaau mai i le 13 13 94.

Atonu e mafai fo'i ona e maua sua se fesoasoani fa'alekulafono mai isi fa'alapotopotoga, e pei o le Legal Aid, se nofoaga fesoasoani fa'alekulafono mo le nu'u, po'o se iuni.<sup>4</sup>

## Ae fa'apefea lo'u visa?

E lē mafai e lau pule ona fa'aleaogaina lau visa, tusa lava pe ua e solia tu'utu'uga o lau visa. Na'o le Department of Home Affairs (Home Affairs), e aofia ai ma le Australian Border Force (ABF), e mafai ona fa'atagaina, te'ena, po'o le fa'aleaogaina o visa.

Ua fa'afulufaleina e le Malo o Ausetalia ni tulafono fou e fesoasoani i le puipuia ai o i latou o lo'o umia visa ma o lo'o feagai ma sauaga i galuega. O nei puipuiga fou o lo'o aofia i le polokalame Strengthening Reporting Protections Pilot.<sup>5</sup>

Atonu e te agava'a mo le ulua'i polokalame pe afai o lo'o e umia se visa le tumau **ma e iai le fa'atagaga e faigaluega ai**.

Afai o oe umia se visa le tumau ma e **lē fa'atagaina lou faigaluega**, o le a iloilo e le Home Affairs lau mataupu i luga o ona tulaga fa'apitoa.

Afai e te agava'a mo le ulua'i polokalame, **e lē fa'aleaogaina** e le Home Affairs lau visa pe a:

- Ua e solia se tu'utu'uga o lau visa e feso'ota'i ma galuega, ma
- E iai se feso'ota'iga i le va o le soliga o lau visa ma se mataupu e uiga i sauaga i le galuega, ma
- Pe a iai nisi o tu'utu'uga ua fa'amalieina.

Mo le maua o lipoti o puipuiga fou, e tatau ona e:

- Ia fa'amaonia lau mataupu e uiga i le sauaga i galuega e se ofisa o le malo o lo'o auai i le polokalame po'o se fa'alapotopotoga fa'amaonia, a'o le'i fa'ailoa atu i le Home Affairs<sup>6</sup>
- Fa'amatala le so'otaga i le va o le mataupu e uiga i le sauaga i galuega ma le soliga o tu'utu'uga o lau visa, ma
- Ia e ta'utino e te usita'i i tu'utu'uga o lau visa i le lumana'i.

Ia fa'ailoa atu i le Home Affairs se mataupu e uiga i le sauaga i galuega, e mafai ona e fa'atumu le Strengthening Reporting Protection Request Process form.<sup>7</sup>

## O ā a'u aia tatau i le nofoaga faigaluega?

E iai tulafono i Ausetalia e uiga i lou aia tatau i le galuega, e pei o le aofa'i maualalo e mafai ona totogiina ai oe (mai le aso 1 lulai 2024, o le totogi maualalo i le itula mo tagata matutua faigaluega tumau po o se vaega taimi o le \$24.10 i le itula), o le aofa'i maualuga o itula e mafai ona e galue ai, ma le taimi e tatau ona e maua ai se malologa. O nei tulafono e mafai ona maua i nofoaga eseese e pei o se fa'ailoga galuega (award)<sup>8</sup> po'o se maliega faigaluega ua lesitalaina (e pei o se

maliega a le kamupani),<sup>9</sup> po o se konakarate faigaluega.

E tutusa aia tatau ma puipuiga masani a i latou e umia visa ma isi tagata faigaluega i Ausetalia i lalo o le Fair Work Act 2009 (Cth).<sup>10</sup>

O nei mea e aofia ai:

- Totogi ma tupe maua – mo se fa'ata'ita'iga, amata i le aso 1 lulai 2024, o le totogi maualalo i le itula mo tagata matutua faigaluega tumau o taimi ma le aufaigaluega i vaega o taimi e \$24.10 i le itula. E masani ona fa'afouina fua fa'atatau maualalo o totogi i tausaga ta'itasi.
- Puipuiga mai le fa'ate'aina ona o auala fa'aletonu (pei o le 'fa'ate'a' pe 'fa'amavae') i nisi tulaga.\*
- Puipuiga mai le fa'ailogia tagata (fa'atauva'a pe fa'aletonu le faiga) ona o le fa'aaogaina o se aia tatau i le galuega – mo se fa'ata'ita'iga, le mafai ona faigaluega ona o le ma'i po'o le manu'a, po'o le faia o se faitioga po'o se fesili e uiga i la latou galuega.
- Puipuiga mai le sauāina fa'afeusuuaiga ma le fa'amalosi i le galuega.
- Puipuiga mai fa'ailogia tagata – e aofia ai le puipuiga mai fa'ailogia fa'alekulafono ona o le matua, a'afiaga tumau o le tino, itupa, ituaiga tagata, fa'asinomaga fa'afeusuuaiga, ma le tapuuaiga.

\*Afaia ua e manatu o se auala fa'aletonu po'o se auala fa'alekulafono ua fa'ate'aina ai oe, e 21 aso ua tu'uina mai e faia ai se tagi i le Fair Work Commission. E iai tulafono ma tu'usaunoaga e fa'atatau i ai. E tatau ona e saili fautuaga e fa'atatau i nei mea i se taimi vave lava.<sup>11</sup>

E tāua le usita'ia o tu'utu'uga o lau visa. Afaia e iai ni ou popolega i lou mafai ona usita'ia tu'utu'uga o lau visa, e tatau ona e talanoa i se sui faufautua malaga ua lesitalaina (RMA), se sui fa'atulafono, po'o le fa'afeso'ota'i o le Department of Home Affairs.<sup>12</sup>

Peita'i, e iai ou aiā tatau ma puipuiga i lalo o tulafono o galuega tusa lava po'o le ā lau tulaga o femalagaa'iga.

E aofia ai tulaga i lalo o le Migration Act pe a e:

- Solia se tu'utu'uga o lau visa,
- E le'o iai sa'u aia tatau e faigaluega ai i Ausetalia i lalo o tu'utu'uga o lau visa, po'o
- Le le umia o se visa.

## O a fa'ailogia i le galuega e fa'atatau i sauaga?

O amioga fa'asauā e mafai ona aofia ai le tele o tulaga e fa'ailoa ai le sauāina o se tagata faigaluega

i le galuega.<sup>13</sup> E mafai ona aofia ai ituaiga eseese o faiga, e pei o:

- Fa'amata'u e fa'apea o le a fa'aleaogaina lau visa.
- Fa'amalosia le faigaluega.
- Umi tele itula galue.
- Totogi maualalo i le galuega ma a'oa'oga e le'i totogia.
- Le 'auina atu o pepa o totogi.
- Le tonu tupe to'ese mai totogi (e aofia ai nofoaga e nonofo ai, a'oa'oga, meai po'o fela'uaiga), tupe teu po'o fuafuaga e toe ave ai se vaega o le totogi ('cash-back').<sup>14</sup>
- Le le mauaina o aia tatau i le galuega, fa'ata'ita'iga, totogi mo aso malolo e aofia ai aso malolo ona o le ma'i ma aso malolo fa'aletausaga, po'o le totogiina o le superannuation.
- O le aveeseina o lau tusifolau ma o lo'o taofia e se isi tagata.
- O le fa'amalosi e te galue i tua atu o tu'utu'uga o lo'o ta'uua i lau visa.
- O le fa'amalosi e totogi muamua se tupe po'o se 'teugatupe' mo se galuega.
- O le taumafai a le pule a le galuega e 'alo ese mai le totogiina o lafoga i le totogiina o oe i se tino i tupe.
- O le fa'avasegaina o oe o se tagata faigaluega tuto'atasi nai lo le avea ma tagata faigaluega masani.
- Galue i ni tulaga lamatia ma e le saogalemu.
- O le tu'uina atu e lau pule i le galuega se nofoaga e le lelei mo le nonofo ai, ma le fa'amalosia o lou totogiina o lea nofoaga.
- Le fa'atagaina oe e te alu ese mai le fale faigaluega.
- Fa'amalosia ia aua ne'i auai i se iuni.

E tupu le fa'aogaina fa'asauā i le galuega pe a le iloa, le malamalama, po'o le le usita'ia e tagata faigaluega aia tatau ma tiute i le galuega, pe ona o le le iloa moni, po'o le faia fa'amoemoeina.

## E fa'apefea ona a'afia a'u aia tatau i le galuega i tu'utu'uga o lo'u visa?

O lau visa Ausetalia e ono iai ni tu'utu'uga e fa'atatau i galuega e mafai ona e faia pe e le mafai ona e faia E mafai e le pule o le galuega ona fai atu ia te oe e fai, pe aua ne'i faia, ni galuega ona o tu'utu'uga o lau visa. Mo se fa'ata'ita'iga, afaia e na'o se galuega fa'apitoa e fa'atagaina i tu'utu'uga o lau visa, e mafai e lau tagata faigaluega ona fa'atonu oe e galue i na o lena matafaioi.

O le tusi fa'amaonia o lau visa o le a aofia ai fa'amatalaga e uiga i tu'utu'uga uma e fa'atatau i lau visa. Pe a le o lea, e mafai ona e siakiina fa'amatalaga o lau visa, e aofia ai tuutuuga o lau visa, e ala i le Visa Entitlement Verification Online: Visa holder su'esu'ega
